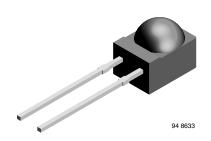




Filter bandwidth is matched with 870 nm to 950 nm IR emitters. The lens achieves 80 % of sensitivity improvement in comparison with flat package. BPV22NFL has long leads, other specifications like BPV22NF.




Fig. 1 - Reverse Dark Current vs. Ambient Temperature




Fig. 2 - Relative Reverse Light Current vs. Ambient Temperature




Fig. 3 - Reverse Light Current vs. Irradiance




Fig. 4 - Reverse Light Current vs. Reverse Voltage




Fig. 5 - Diode Capacitance vs. Reverse Voltage




Fig. 6 - Relative Spectral Sensitivity vs. Wavelength






Fig. 7 - Relative Radiant Sensitivity vs. Angular Displacement




